DC SHOES, INC.'S TRASE SHOE GIVEAWAY SWEEPSTAKES

OFFICIAL RULES

- 1. **Who Can Enter**: Any legal resident of the U.S. or Canada (excluding Quebec), 13 years of age or older, is eligible to participate in DC Shoes, Inc.'s Trase Shoe Giveaway Sweepstakes (the "Sweepstakes").
