

**ROXY'S READY FOR FRANCE PRIZE PACK GIVEAWAY SWEEPSTAKES**  
**PROMOTION– OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER. VOID WHERE PROHIBITED BY LAW.

1. **Who Can Enter:** Any legal resident of the U.S. or Canada (excluding Quebec) 13 years of age or older is eligible to participate in Roxy's Ready for France Prize Pack Giveaway Sweepstakes (the "Sweepstakes"). Employees, officers, principals, directors or agents of Quiksilver, Inc. or their subsidiaries or affiliates (collectively, the "Sponsor"), and members of their households or immediate families, are not eligible to participate.

2. **How to Enter:** Each entrant must register and complete the online entry form at [www.roxy.com/profrance](http://www.roxy.com/profrance). The online entry form must be submitted between 12:00 a.m. PST on September 22, 2014 ("Sweepstakes Open Time") and end at 11:59 p.m. PST on October 7, 2014 ("Sweepstakes Close Time").

3. **Sweepstakes Dates:** The Sweepstakes will begin at the Sweepstakes Open Time and end exactly at the Sweepstakes Close Time. The prize drawing will be held based on number of eligible Sweepstakes entries properly submitted, completed and received between the Sweepstakes Open Time and the Sweepstakes Close Time.

Entries will be deemed to have been submitted by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

4. **Prizes:** One (1) winner will be chosen at random. The winner will receive a Roxy Ready for France prize pack including: one (1) Roxy wetsuit, two (2) Roxy Outdoor Fitness outfits, one (1) Roxy bikini, one (1) Roxy luggage, in such styles and sizes as determined by Sponsor in its sole discretion, and a five hundred dollar (\$500 USD) Roxy gift card. The prize has an approximate retail value of \$1,235.00 USD. The redeemable gift card has no cash value, and can only be used for merchandise at participating Roxy locations and online at Contest Sponsor's e-commerce site in the country of winner's residence. Gift cards will not be exchanged for cash under any circumstances. All prizes are "AS IS" without any warranty of any kind, express or implied. No substitution, exchange or transfer of prizes will be made or is permitted.

5. **Prize Drawings:** The winner will be selected in a random drawing conducted by the Sponsor based on eligible entries properly submitted between the Sweepstakes Open Time and the Sweepstakes Close Time. The prize drawing for the Sweepstakes will be held at Sponsor's headquarters in Huntington Beach, California on October 8, 2014. The winner's name will be posted on [www.roxy.com](http://www.roxy.com) and the Roxy Blog.

6. **Odds of Winning:** Each entrant's odds of winning are dependent on the aggregate number of eligible entries properly submitted between the Sweepstakes Open Time and the Sweepstakes

Close Time. No purchase of any kind is necessary in order to enter the Sweepstakes or win any prize, and chances of winning are not enhanced by making any purchases.

**7. Winner Notification:** The winner will be notified via e-mail within 48 hours of awarding of prizes (which is currently anticipated to occur on or around October 8, 2014). The winner will be required to respond to the e-mail notification to acknowledge receipt of Sponsor's notification and awarding of prizes. If no response is received by Sponsor from winners within three (3) calendar days following the prize notification email, the prize will be awarded to a replacement winner to be determined by the Sponsor in the Sponsors' sole and absolute discretion. The winner will be required to prove eligibility to receive and claim any prize. Any winner who is under 18 years of age will be required to have written parental consent to the entrant's entrance, awarding acceptance and receipt of the prize, and to all of the conditions and terms set forth in these Official Rules.
